## Plan your Professional Development

### Including All Children and the Americans with Disabilities Act (ADA).

All family child care providers, including assistant teachers in large family homes, and all child care center directors, teachers and assistant teachers are required to take this class.

### Medication Administration

This six-hour training is now required for all family child care providers and child care centers are required to have one person on site at all times who has been trained in Medication Administration. If you have already taken the Medication Administration training, you will not need to take it again. Our Medication Administration class is limited to 10 participants per class. Please cancel at least 24 hours in advance if you are unable to attend so that those who are waiting to attend the class can be accommodated. There will be NO refunds. If you would like to transfer you must give 24 hours notice in advance. Medication can only be administered to a child in care by an individual who has completed the approved training.

### On Track: All Aboard for Developmental Progress Overview

This four hour class will be required for all family child care providers, center directors and lead teachers in child care centers.

**Supporting Breastfeeding in Child Care**  
Staff in any program approved for infant and toddler care (group and family programs) must complete approved training in breastfeeding practices.



## Resource Center Training Policies

The Resource Center is proud of the training sessions that are developed and presented at PGCRC for the child care providers of Prince George's County. We know that you are on the front line when it comes to preparing our children for school and for life, and we are grateful that you come to us for training. Our goal is for every training session to meet Maryland State Department of Education standards and be interesting, informative and high quality.

In order to make our classes available to as many people as possible, all registration is on a first-come basis. Class size may be limited so early registration is always suggested. Register online at [www.childresource.org](http://www.childresource.org) for the best selection of classes. You may also download a registration form and mail or fax (301.772.8410). We accept Visa, Mastercard, Discover, American Express, checks or money orders. We do not accept cash. All payments and registrations must be received 24 hours in advance; we add a walk-in charge of \$20 to registration fees on the day of the workshop. There are NO Refunds unless the class is cancelled by the Resource Center for low enrollment. You must request a transfer 24 hours in advance.

Participants arriving late will not be admitted to the class and late arrivals are not eligible for a transfer or refund. And, even though we love children, only adults are admitted to our workshops. Certificates are only awarded to those participants who fully participate in the class and who pass the assessment for the training. Assessments are usually written but may be embedded in class participation activities. We are happy to offer technical assistance without charge to any provider who does not pass the assessment. Attendance at training is not a guarantee that a certificate will be given.

## The LOCATE Complaint Policy

When a complaint is received by LOCATE, it is categorized according to the seriousness of the complaint: serious complaint (any threat to the immediate health, safety or welfare of a child); less serious complaints involving a violation (violation of regulation that does not pose a threat to the health, safety or welfare of a child); and less serious complaints with no violation. When a serious complaint is received, no referrals are made to that provider/facility until an investigation is completed by the appropriate regulatory agency. Should the investigation result in no finding, the "hold" status is removed from the provider's files and referrals are resumed.
