## Plan your Professional Development: REQUIRED CLASSES

### Including All Children and the Americans with Disabilities Act (ADA)

All family child care providers, including assistant teachers in large family homes, and all child care center directors, teachers and assistant teachers are required to take this class.

### Medication Administration

This six-hour training is now required for all family child care providers, and child care centers are required to have one person on site at all times who has been trained in Medication Administration. If you have already taken the Medication Administration training, you will not need to take it again. This class is limited to 10 participants per class. Please reschedule at least 24 hours in advance if you are unable to attend so that those who are waiting to attend the class can be accommodated. There will be NO refunds. If you would like to transfer you must give 24 hours notice in advance. *Medication can only be administered to a child in care by an individual who has completed the approved training.*

### On Track: All Aboard for Developmental Progress Overview

This four-hour class will be required for all family child care providers, center directors and lead teachers in child care centers.

### Supporting Breastfeeding in Child Care

Staff in any program approved for infant and toddler care (group and family programs) must complete approved training in breastfeeding practices.

## Where Literacy Begins

PGCRC is teaming up with WETA Kids Channel to present a special series of four trainings for infant and toddler teachers in child care centers or family child care providers who are caring for infants and toddlers. ## Basic Health and Safety Training

You may have heard that there is some new required training. We anticipate that "Basic Health and Safety Training" will become required per COMAR regulation sometime this year. The training will provide an overview of basic health and safety topics including prevention/control of infectious diseases, SIDS, shaken baby syndrome and head trauma, food allergies, vehicle transportation safety, child abuse, building safety, and others. This overview is intended to familiarize child care providers with a basic understanding of these areas with opportunities for additional professional development. The workshop was developed by the American Academy of Pediatrics and is based on Caring for Our Children, an exemplary resource in early childhood education caregiving standards. The workshop will satisfy the anticipated COMAR regulations and will provide Core of Knowledge Hours. The Resource Center will begin offering the workshop as soon as it becomes available.

## The LOCATE Complaint Policy

When a complaint is received by LOCATE, it is categorized according to the seriousness of the complaint: serious complaint (any threat to the immediate health, safety or welfare of a child); less serious complaints involving a violation (violation of regulation that does not pose a threat to the health, safety or welfare of a child); and less serious complaints with no violation. When a serious complaint is received, no referrals are made to that provider/facility until an investigation is completed by the appropriate regulatory agency. Should the investigation result in no finding, the "hold" status is removed from the provider's files and referrals are resumed.
