## **PGCRC and the Maryland Child Care Resource Network**

The Maryland Child Care Resource Network (MCCRN) provides leadership and services designed to improve the quality, availability, and affordability of child care in communities across the state. PGCRC is proud to be one of the three “original” members of MCCRN, which now has twelve regional Child Care Resource Centers (CCRCs). The CCRCs that comprise the Network provide high quality training opportunities and provide technical assistance to child care providers throughout Maryland. Child care training is now being shared among the Resource Centers which enables us to expand our training opportunities. Check out the offerings in this edition of the training calendar – you will find many new offerings thanks to the expansion of our partnership. All training offered is approved by Maryland State Department of Education and meets all requirements. PGCRC will now issue certificates under two different training numbers: our original COK training number and the MCCRN training number. The certificates will be distinct to the training number, but be assured that both numbers represent the highest quality training available in Maryland. Take a look at our new offerings – and enjoy a new training experience this summer.



## Plan your Professional Development

### Including All Children and the Americans with Disabilities Act (ADA).

All family child care providers, including assistant teachers in large family homes, and all child care center directors, teachers and assistant teachers are required to take this class.

### Medication Administration

This six-hour training is now required for all family child care providers and child care centers are required to have one person on site at all times who has been trained in Medication Administration. Medication can only be administered to a child in care by an individual who has completed the approved training.

### Supporting Breastfeeding in Child Care

Staff in any program approved for infant and toddler care (group and family programs) must complete approved training in breastfeeding practices.

### Basic Health and Safety Training

This training is now required for all family providers, teachers, assistant teachers and child care center directors. It will provide an overview of basic health and safety topics including prevention/control of infectious diseases, SIDS, shaken baby syndrome, head trauma, food allergies, vehicle transportation safety, child abuse, and others. This class will satisfy the new COMAR regulations for the Basic Health and Safety training.

## LOCATE: Child Care and You

LOCATE: Child Care is the only free, comprehensive, and individualized database with information on all regulated child care in Maryland. LOCATE is the greatest free marketing service available to child care programs and providers! Families who contact LOCATE receive help in identifying and choosing child care that meets their individual needs.

LOCATE is most effective when the information on your program is complete and up-to-date! LOCATE now offers you the ability to update your information online! To take advantage of this service go to [marylandfamilynetwork.org](http://marylandfamilynetwork.org), click on LOCATE Child Care, then For Child Care Providers, and finally choose to update online or download and print a form specific to your program and mail to LOCATE Child Care at the address on the form.

## The LOCATE Complaint Policy

Through the LOCATE service, parents share feedback with the LOCATE staff on the programs in the files: licensed child care centers, registered family child care providers and accredited preschools and camps. While this feedback is at times positive, it sometimes concerns complaints parents have about child caregivers. Of course, LOCATE and the Maryland Child Care Resource Network want to use this information in a way that is fair to providers and parents, while protecting children, as well.

Therefore, the LOCATE Complaint Policy was developed and has been in effect since its approval by the Maryland Committee for Children Board in November, 1983. According to this policy, all complaints made to LOCATE about child care providers/facilities are recorded. The type of complaint is then determined:

**Less Serious Complaint - No Violation:** complaints which do not involve violations of child care regulations; complaints about situations which do not pose a threat to the safety, health or welfare of a child.

**Less Serious Complaint Involving Violation:** complaints of any violation of Office of Child Care (OCC), Maryland State Department of Education (MSDE) regulations, and/or the Health Department which do not pose a threat to the health, safety or welfare of a child.

**Serious Complaint:** any threat to the immediate health, safety, or welfare of a child.

When a parent calls LOCATE with a complaint, the referral specialist advises him/her to register the complaint directly with the appropriate regulatory agency and/or Protective Services. Names and telephone numbers of the person with whom the parent should speak are provided.

When a Serious Complaint is received concerning one of the providers or facilities in the LOCATE system, no referrals are made by the referral specialists to that provider/facility. The LOCATE Director also communicates with the appropriate regulatory agency personnel about the complaint, and maintains the "hold" on the provider/facility until the agency's disposition of the complaint is known. Should the investigation result in no action, the "hold" status is removed from that provider's/facility's records. Should the license or registration be revoked, the record is removed from the LOCATE files. Providers are advised of LOCATE's actions in writing.

A provider may appeal the LOCATE Director's decision to cease referrals. Appeals are first addressed to the LOCATE Advisory Committee. Final appeals may be made to the board of the Maryland Family Network.

It is the position of LOCATE and MFN that the Complaint Policy is both fair and workable. Safeguards and due process are afforded to the care givers in the files, and parents' and children's rights to safety are addressed, as well. We have a great new way for child care providers to earn Professional Activity Units for the Child Care Credential: join our Learning Community! Beginning in July we will have monthly two hour sessions on current interest topics such as "Purple Tears - the Period of Purple Crying" and "Library Time with Infants and Toddlers." We will be adding new topics each month. Providers who attend three sessions will earn one (1) Professional Activity Unit (PAU). ## Resource Center Training Policies

We know that you are on the front line when it comes to preparing our children for school and for life, and we are grateful that you come to us for training. Our goal is for every training session at PGCRC to meet Maryland State Department of Education standards and be interesting, informative and of the highest quality.

In order to make our classes available to as many people as possible, all registration is on a first-come basis. Class size may be limited so early registration is always suggested. We accept Visa, Mastercard, Discover, American Express, checks or money orders. **Cash is not accepted.** All payments and registrations must be received 24 hours in advance; we add a walk-in charge of \$20 to registration fees on the day of the workshop. Transfers must be requested 24 hours in advance. If a transfer is requested after a class has been missed, appropriate documentation such as a doctor's note

will be required.

**Please be aware of the following:**

- **There are NO Refunds unless the class is cancelled by the Resource Center for low enrollment or weather.**
- Late arrivals will not be admitted to the class and are not eligible for a transfer or refund - **there are no exceptions to this policy.**
- Only one pre-arranged transfer will be allowed and must be within two months of the **original** registration.
- Only adults are admitted to our workshops.
