## Let us bring training to you!

ON-SITE REQUEST FORM

If you have a group of staff that numbers 10 or more, in need of the same training, one of our trainers can come to your center. Our trainers are also available for virtual on-sites. Fill out our on-site request form by clicking below, and we will follow up to schedule with you.

A minimum of 3 weeks notice is required.





# **Training Policies**

- **Please be on time.** For in-person trainings the door is locked once the workshop begins, and you will not receive a certificate, refund, credit, or transfer if you are late or unable to attend.
- For virtual trainings, the meeting will be locked and you will not be admitted.
- For *virtual* trainings, your camera must be on for the entirety of the workshop. Reports are checked for attendance and participation.
- **Attendance** at training is not a guarantee that a certificate will be given. They are only awarded to participants who: are present for the whole class, fully participate, pass the assessment with an 80% or higher, and complete the evaluation.
- **Certificates** are provided 10 business days following the completion of the required assessment and evaluation for the course.
- There are no **refunds** unless Child Resource Connect cancels the workshop.
- **Credits** must be used within 90 days of issuance. Any unused credits at the end of 90 days are forfeited.
- **Transfers** are granted only when requests are received at least 24 hours before the workshop. Requests must be made in writing via email to training@childresource.org. Only pre-arranged transfers will be permitted and must be within 2 months of the original registration.
- **Certificate replacements** are \$5 and will be enforced for both emailed and printed certificates. Please preserve a copy of all training certificates that are provided to you via email and/or physically for your records.
